We pay our respects to past, present and future Elders and recognize their strong physical, spiritual and cultural connections to their ancestral lands.






MISSION STATEMENT

WHAT MAKES OUR GOLD "ETHICAL" AND "CLEAN"

The Prospectors Club aims to bring the world the best Australia gold we can, we are dedicated to enhancing environmental sustainability efforts.

Being small scale prospectors and gold buyers we can guarantee a transparent supply chain all the way. The Prospectors Club aims to bring the world the best Australia gold we can, we are dedicated to enhancing environmental sustainability efforts.Being small scale prospectors and gold buyers we can guarantee a transparent supply chain all the way.

We have outlined some of the reasons why our gold is some of the most "ethical" and "clean" in the world -

- Offering prospectors wages exceeding industry standards.
- Providing a mobile service to reach remote communities with high indigenous populations, facilitating the sale of their gold as many cannot travel to Kalgoorlie for this purpose.
- Purchasing exclusively from small-scale alluvial gold prospectors, eliminating the use of cyanide or mercury in the process. Additionally, as there is no ore crushing involved, natural arsenic release into the environment is minimized.
- Operating within Australia's stringent labor laws, ensuring fair wages and treatment for all involved. This stands in contrast to larger mines in less developed regions that may lack such protections.
- Sourcing gold exclusively from the outback of Western Australia, with no byproducts released into major water sources and no excavation through permafrost, thereby minimizing CO2 emissions.
- Adhering to strict reclamation laws in Australia.
- Procuring gold from small mines with minimal land disturbance. We do not create or source from open cut mines, the only land disturbance create by our work is small amounts of land being stripped and the dirt pushed back to reveal the gold. After a certain amount of tonnage we rehbilite the land before mocing to the next section. This is done about everything month. As a requirement of having a mining lease in Western Australia you have to have a strict mining plan that includes all land and animal disturbance and how you a rehabilitating that. The mines department do conduct checks.
- Committing to the preservation of natural forests, protected areas, and reserves by ensuring no destruction occurs. These areas are off limits.
- Respecting native title rights and acknowledging the need for improvement in Western Australia's native title laws. The company remains receptive to Indigenous voices for ongoing enhancement.



What sets us apart is our dedication to releasing significantly less CO2 than other mining techniques, ensuring a cleaner and greener approach to gold extraction.



Our family-oriented team, includes Tyler, her parents Ted and Lecky and her brother Reece, working harmoniously to uphold our values and ethical standards. The Prospectors Club not only engages in gold mining but also deals in ethical, clean gold.

We actively purchase gold from local smalltime prospectors who utilize metal detectors, paying them one of the highest gold rates globally. This not only supports local fossickers but also reinforces our commitment to fair and sustainable practices.

Situated in the heart of Kalgoorlie, our gold dealership not only calls this historic mining town home but proudly conducts prospecting operations throughout the vast and resourcerich landscape of Western Australia.

While our roots are deeply anchored in Kalgoorlie, our prospecting ventures extend far beyond, covering various regions across the state.

HOW OUR GOLD IS FOUND

The gold we find and procure originates from prospecting and small scale mining activities with minimal land and water disruption. Our sourcing methods primarily involve:

METAL DETECTING

Prospectors utilize metal detectors to locate gold, resulting in very minimal land disturbance. The gold is typically found within four feet of the surface and only a small hole is created to extract the gold, this hole is then filled in.

The majority of this gold is acquired from prospectors operating on public ground under a miners' right, where the use of machinery and powered tools is prohibited. This ensures a lowimpact approach to gold extraction, aligning with our commitment to environmental stewardship.

SCRAPE AND DETECT OPERATIONS

In this method, loaders or excavators delicately remove small amounts of dirt, revealing deeper ground for metal detection of nuggets.

This process, conducted in small increments, minimizes disruption to the land.

REHABILITATION PROCESS

The earth is stripped back to reveal nuggets in deeper ground.





After the nuggets have been extracted we begin pushing the dirt back.







REHABILITATION PROCESS

We then create divits and grooves with the teeth of the loader to capture seeds and encourage growth.





The trees that were orignally moved are placed back on top of the ground, there seeds will naturally germinate.





Pictured is an area of ground we rehabilitated, you can see the regrowth is thick and healthy.


ENVIRONMENTAL IMPACT

In 2023, we have dedicated a team to tracking, reporting on and improving our environmental management practices to create transparency in our company.

The Prospectors club stance on the climate crisis

- Acknowledging the science of climate change as reported by the Intergovernmental Panel on Climate Change.
- Committed to diligently tracking CO2 emissions and actively pursuing reductions each year.
- Maintaining emissions levels considerably below industry averages.
- Recognizing the significance of understanding and responding to climate change risks.

CARBON FOOTPRINT

In 2023, The Prospectors Club's small-scale family mine yielded 0.19 tons of CO2 per ounce, marking a 75.5% reduction compared to the global average of 0.8 tons of CO2 per ounce, as per a 2019 report by S&P Global.

This calculation demonstrates the CO2 emissions output of our family-owned gold mining venture, showcasing our minimal machinery usage and limited ground disturbance. Moreover, the CO2 footprint associated with the gold sourced from local prospectors is even lower, with 95% of them employing manual techniques like metal detecting, minimizing reliance on machinery.

It's important to highlight that this formula does not encompass individual CO2 emissions, prompting us to broaden our assessment to include personal emissions as part of our ongoing environmental evaluation efforts.

GHG protocol

The greenhouse gas protocol (GHG) outlines three different categories of emissions that are widely used and accepted. For the purposes of this report, we have determined our findings based on scope 1 emissions only. Carbon output from upstream and downstream activities were not included.

Emissions released through exploration, suppliers, gold refineries, waste disposal and transport of materials by a third party were not factored into our calculations.

The S&S Committee has set a goal to track and report on LFM's scope 2 emissions by 2023.

limitations These findings do not incorporate emissions originating from the individuals from whom we acquire gold. Additionally, the results do not factor in emissions stemming from the transportation of our gold to international buyers. As part of our ongoing commitment to environmental transparency, we aspire to expand our tracking efforts beyond scope two emissions in the future, acknowledging the importance of a comprehensive assessment that considers the entire lifecycle of our gold transactions.

<u>*Scope guidelines based on criteria outlined by United States Environmental Protection</u> <u>Agency (EPA)</u>

Released directly into the air through output of activities controlled or owned by an organization. Includes emissions from furnaces, generators, mobile sources (equipment and vehicles), industrial processes and waste or wastewater treatment.

MITIGATED ENVIRONMENTAL RISK

To extract gold, hard rock mines must blast and breakdown ore which causes naturally occurring arsenic and harsh chemicals to leach into the surrounding environments. As the rock ages, it emits more of these chemicals and continues to cause damage.

The cyanide from the extraction process and the leaching from the breaking and blasting pose two significant risks with hard rock mining. Alluvial mining does not involve the breaking down of hard rock ore and does not employ any chemical extraction process to retrieve the gold from the ore, and instead relies on gravity methods only. Mercury poses a risk of irreversible damage to the local environment and surrounding areas.

The alluvial mining we conduct and source from does not involve the use of mercury and therefore does not pose the same risk for environmental disaster as other mining methods.

SOCIAL PERFORMANCE

In 2023 The Prospectors Club bought over \$150,000 worth of gold from local prospectors, money that goes directly into the community and allowing prospectors do carry out their passion. In 2024 we are on track to do \$400,000.

This number does not include the profits from our small scale mine which also directly benefits the local community.
